EXECUTIVE BOARD MEETING MINUTES

CALL TO ORDER Sheriff Morris called to order at 9:32 AM.

Approval of Minutes for 5/24/2023: Motion by Chief Vance. Second by Chief Bennett. Motion carried.

FINANCE COMMITTEE REPORT: Chief Vance gave the board a finance report.

2022 Financial Statement and Federal Grant Audit – The audited financial statements and final exit meeting occurred in July. As previously discussed, no findings or concerns were issued by the auditors.

2019-2021 State Auditor's Accountability Audit – Members of the Executive Board, WASPC staff and the State Auditors office met in July to receive the accountability audit report. No findings were issued.

Financial Statements - The comparative statements are presented through June. No concerns to note in the presentation. Expenses and revenues are as expected.

Monitoring Revenues/Expenses – Lost/damaged equipment revenues and expenses significantly reduced from prior year as staff has been working with the DOC to better manage and recover equipment used by their agency. Other monitoring revenues is on track with 2022.

Sales Revenues – Lease income is lower in 2023. The only active lease is for the CJTC financial staff workstations.

Disbursements: Check number 45536 through 45992 (04/30/23- 9/14/2023) for \$13,108,931.26 (full listing provided in board packet)

Jamie Weimer gave an update on the Sex Offender Model Policy Update 1394 – Model Policy will need to be updated by membership at the General Business Meeting at the Fall conference in November 2023. Changes need to be drafted for review by July 1, 2024 for legislature.

Motion to approve by Chief Lowe. Second by Sheriff Thurman. Motion carried.

David Doll gave an update on Accreditation Commission Appointment - As of July 1st, 2023, there are two changes in the makeup of the Accreditation Commission I recommend and that require Board action. In summary those changes include:

Move Kent Police Chief Raf Padilla from Chief Appointment to Jail Manager Appointment; and Appoint Anacortes Police Chief David Floyd to Chief Appointment vacated by Chief Padilla.

I follow the same practice of our former Professional Services Director, Mike Painter, in consideration of advancing candidates for Accreditation Commissioner using the following criteria:

- 1. Must be from a current WASPC accredited agency
- 2. Experience with the WASPC accreditation program
- 3. Demonstrated good judgement
- 4. Geographical balance with representation from both eastern and western Washington
- 5. Ability to consistently attend Accreditation Commission meetings

I make the following recommendations:

Filling the two Jail Manager accreditation commission positions continues to be a challenge as there are currently five jails accredited with several of those jails experiencing recent turnover in leadership, making it difficult to find a jail manager that meets the aforementioned criteria – especially experience with our accreditation program. While time in position and continued work with the accreditation program will provide more future choices, we are now faced with a jail manager vacancy due to the following recent retirement:

Accreditation Commissioner Diane McCuiston retired from Kent Police Department Corrections in July of this year, leaving an unanticipated opening as her term was scheduled to expire in 2025.

To fill that spot I recommend moving Accreditation Commissioner Raf Padilla from the Chief Appointment to the Jail Manager Appointment as Chief Padilla currently runs a WASPC accredited in Kent.

I further recommend appointing Chief David Floyd, from Anacortes PD, as a new commissioner to fill the "Chief Appointment" vacated by Chief Raf Padilla. Chief Floyd is from an accredited agency, is a former accreditation manager, mentor and assessor and recently mentored Anacortes PD to a successful re-accreditation. Chief Floyd currently serves as a LEMAP assessor and continues to be active in our accreditation program.

Motion to approve these changes by Sheriff Myers. Second by Chief Bennett. Motion carried.

The Board received a presentation on OII/IIT Investigations by Chief Dan Christman—Selah Police Department & Captain Brian Chance—Wenatchee police department. The Chief & Captain are requesting WASPC create an ADhoc "Independent Investigation Committee". The purpose of the committee would be: Provide perspective and input to assist CJTC in development of realistic and meaningful investigative guidelines, documentation, and reporting standards through engagement with stakeholders and Commission, Engagement and discussion with OII & Report out to WASPC membership with current information and trends.

Motion to approve ADhoc Committee by Chief Padilla. Second by Chief Bennett. Motion carried.
