Team Approach

- Working with the Cities to effectively manage RSO's in Clallam County.
- Developing relationship with local D.O.C.
- Establishing a productive agreement and system with Prosecutor's Office to effectively charge FTR's.
- Developing a relationship with local Tribes in management of Clallam County RSO's



Verifications

- What prompts a verification?
 - Regularly scheduled verification
 - Address change
 - Intel of non-compliance
- CCSO vs City verifications
- Verified
 - Verifying elements on verification form
 - Gathering Intel at time of verification
- Determined to have failed to register.

Writing the Report for Prosecution

- If deemed failed to register, CCSO Civil Deputy writes case report on offender's fail to register to provide necessary elements in with the prosecutor can charge the case.
 - Name of Offender, level
 - Crime in which requires offender to register, level of crime, date of conviction, county of conviction
 - Statutes in which the offender is non-compliant.
 - Elements in which show the offender is aware of the requirements and obligations of registration.
 - Initial Registration
 - Verbal Understanding by the Offender

Residential Fail to Register


- Prove our burden of 72 hours.
- CCSO checks both day and night for up to 80 hours to establish if they have been away from their registered address for longer than 72 hours.
- Other elements in which can assist a case; pictures, tape on doors, witness statements etc.

Transient Fail to Register

- Check-in once a week as established by the Sheriff.
- Offenders are given one warning, per agreement with the Prosecutor's Office.
- The very first no-show on homeless check in day is a verbal / written warning provided by the Civil Deputy.
- Every subsequent non-compliancy will result in arrest, no exceptions.

Prosecutor Prospective

- <u>Autonomous</u>: Organizations operate independently.
- <u>Cooperative</u>: Remain independent, but network and share information; Low commitment; Informal arrangements.
- <u>Coordinated</u>: Some joint planning; Often project-based coordination; Medium commitment; Semi-formal partnerships;
- <u>Collaborative</u>: Shared culture, visions, values and resources; Joint planning and delivery of some services; High commitment; Formalized partnership.
