## End of Session Report 2015 3<sup>rd</sup> Special Session

Monday, July 13, 2015

This report covers bills passed by the Washington State Legislature during the 2015 3<sup>rd</sup> Special Session (June 28, 2015 – July 10, 2015).

Bills passed by the Legislature are subject to [executive action by the Governor](#).

Unless otherwise noted in the text of the legislation, these bills become effective on October 9, 2015.

Nothing in this report should be interpreted as legal advice. The 'Short Descriptions' are a brief summary of the most substantive provisions of a bill. Please reference the actual text of legislation.

Bill #	Abbrev. Title	Short Description
<a href="#">HB 2217</a>	Juvenile offender basic training camp	Eliminates the requirement, but still allows, the Department of Social and Health Services to operate a medium security juvenile offender basic training camp program.
<a href="#">SSB 6134</a>	Pretrial alcohol monitoring	The \$150 limitation on costs for pretrial supervision does not apply to those for pretrial electronic alcohol monitoring, drug monitoring, or the 24/7 sobriety program. In cases involving driving under the influence or being in physical control of a motor vehicle while under the influence, if electronic monitoring or alcohol abstinence monitoring is ordered, the court must specify (1) who will provide the monitoring services, (2) the terms under which the monitoring is performed, and (3) upon conviction, the court may require as a condition of the sentence that the defendant reimburse the providing agency for the costs of the electronic monitoring or abstinence monitoring.
