#### **OWSOR Overview**

The Offender Watch & Sex Offender Registry Interface (OWSOR) is a collaborative initiative by the Washington State Patrol (WSP) and the Washington Association of Sheriffs and Police Chiefs (WASPC) to retrieve data from the Offender Watch (OW) system and automatically update the WASIS system with that data.

As a result, OWSOR achieves a reduction in redundant work and a minimization of manually processing data. Thus, improving the accuracy, consistency and timeliness of the SOR data stored in WASIS.

#### **OWSOR: The Schedule**

OWSOR is designed with a two-day delay. No OW data will be processed against WASIS until two working days have passed, to ensure the base registration record has been processed at WSP before attempting to link the photo and any other updates.

#### **OWSOR: Data Retrieval**

Data is retrieved electronically through the interface when information is updated by the county coordinator in the WATCH system. When a new sex offender registration is received in W2 through ABIS, it does not automatically pull data (i.e. updated images) from the WATCH system. The county coordinator will need to update data within WATCH for it to trigger sending data to the OffenderWATCH interface.

## **OWSOR: The Matching Process**


Once a record is received from OW, OWSOR will attempt to find a matching record in the WASIS system based on the SID, Name, DOB and County.

- If all four criteria match, the OW record is considered an exact match to the WASIS record.
- If all criteria except for SID match, OWSOR will send a notification to the county coordinator(s) that the SID on file at OW does not match the SID on file at WASIS, prompting the county to update the OW SID information. The OW record is considered a match with incorrect SID, and WASIS is updated with the SID it has determined to be correct.
- If there are no matches, OWSOR will send a notification to the county coordinator(s) that a new registration must be sent to WSP.
- If there are two or more matches, OWSOR will send a notification to the county coordinator(s) that a SID is needed because too many matches were found.

Please note: The provided data (name, date of birth, and county) must correspond exactly with what is in WASIS for it to match up and update the existing record.

# **OWSOR: What Is Updated?**

Once a match is found in WASIS, OWSOR will check to see if there is a new status, level, or any new addresses or images for that record.

# **Update Conditions:**

\*\*Incoming records are first verified that they are coming from the same county they are currently registered with in WASIS. If not, a new registration notice is sent to the sending county.

## **OWSOR: What Can You Expect?**

If everything processes successfully, the OWSOR process will result in a possible status, address and/or image update. In this case, there will be no notification sent and no further action required. In some cases, the OWSOR process will result in an email notification to the county coordinator(s). This email will notify the coordinator(s) that further action needs to be taken.

#### **Transmission Error**


There are different reasons why a transaction fails to update WASIS. It is usually due to the missing or incorrect data provided on the date of submission. Below are some examples with solutions.

#### **Start Date Is Greater Than End Date**



**Resolution:** WASIS cannot update an address if the end date is before the start date. The county coordinator will need to update the information so that the end date occurs after the start date.

#### **Required Fields Missing**



**Resolution:** WASIS cannot update an address if required information is not provided. The county coordinator will need to include the city and zip for this offender's updated address.

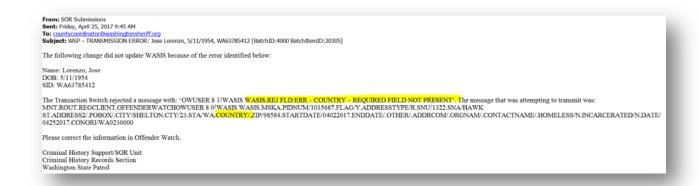

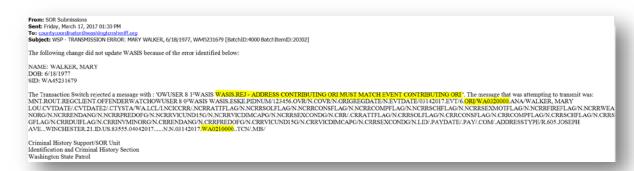

# **OWSOR: Tips For Success**

Below are some tips that will ensure OW records are updated in WASIS.

- 1. Please make sure to use a valid OW status when updating a record. Older records will likely have invalid statuses, so make a habit of checking the OW status before submission. Recognized statuses include the following:
  - Active
  - Active Absconded
  - Active Local Jail
  - Active Transient
  - Inactive-Incarcerated
  - Inactive-Reg. Expired
  - Inactive-Out of Area
  - Inactive-Deceased
  - Inactive-Deported
- 2. Please make sure that <u>ALL</u> addresses for an offender have the required fields entered. In order for an address to be complete and accurate, the following fields are required: Street Number, Street Name, City, State, Zip, County, Country, Start Date, and Contributing ORI. This will also ensure that the OWSOR process can determine which address is the most recent for an offender.
- 3. Addresses cannot have future start dates that are more than one month in advance of the current date. If they are over a month, the submission will be rejected.
- 4. New addresses must have a start date that is later than the most recent address start date in WASIS.
- 5. Any addresses or images over sixty days old will not be updated in WASIS.
- 6. Addresses with any of the following key words in the street name will not be updated in WASIS:
  - Verify
  - Unknown
  - Fail
  - Failure
  - Relieved
  - Releived (common typo)
  - Deported
  - Deceased
  - Warrant
  - Out of State
- 7. Please be sure to include proper spacing, hyphenation, and spelling within the offender's name. If the name is not entered using the correct format as listed on the fingerprint card and variances are



not listed as one of their AKAs, it will not be considered a match with the existing WASIS record. A single hyphen is allowed in the last name; no hyphens are allowed in the first or middle names.

- 8. Please make sure that <u>ALL</u> images have an image date included with them. This will ensure that the OWSOR process can determine which image is the most recent for an offender.
- 9. Please make sure any photos submitted for new registrations have an image date matching the date of registration.
- 10. Please update the SID for an offender in OW if you receive a notification of the WASIS SID on file. This will ensure a smoother process in the future, and will improve the completeness and accuracy of data.
